

Before Starting the Project Listings for the CoC Priority Listing

The CoC Consolidated Application requires TWO submissions. Both this Project Priority Listing AND the CoC Application MUST be completed and submitted prior to the CoC Program Competition submission deadline stated in the NOFO.

The CoC Priority Listing includes:

- Reallocation forms – must be completed if the CoC is reallocating eligible renewal projects to create new projects or if a project applicant will transition from an existing component to an eligible new component.

Things to Remember:

- New and Renewal Project Listings – all project applications must be reviewed, approved and ranked, or rejected based on the local CoC competition process.
- Project applications on the following Project Listings must be approved, they are not ranked per the FY 2023 CoC Program Competition NOFO:

- UFA Costs Project Listing;
- CoC planning Project Listing;
- YHPD Renewal Project Listing; and
- YHDP Replacement Project Listing.
- Collaborative Applicants are responsible for ensuring all project applications accurately appear on the Project Listings and there are no project applications missing from one or more Project Listings.
- For each project application rejected by the CoC the Collaborative Applicant must select the reason for the rejection from the dropdown provided.
- If the Collaborative Applicant needs to amend a project application for any reason, the Collaborative Applicant MUST ensure the amended project is returned to the applicable Project Listing AND ranked BEFORE submitting the CoC Priority Listing to HUD in e-snaps.

4-2. Describe how the CoC determined that this project should be reduced and include the date the project applicant was notified of the reduction. (limit 750 characters)

AL0034 was reduced to reallocate funds to a new DV project in Baldwin County, Alabama (the CoC's geographical area). The CoC determined a need for a CoC-funded DV project in this area. The sub-recipient for AL0034 is a non-profit conglomerate integrated healthcare system serving the mentally ill throughout South and East-Central Alabama. AL0034 was not reduced based on its performance or management of the grant, and the services provided/population it serves (housing services for homeless persons diagnosed with mental illness) are essential to the CoC's service area. The CoC's decision to reduce the grant's ARA was solely to reallocate funding from a lower-ranked renewal project to a new, high-priority project serving victims of domestic violence.

4-2. Describe how the CoC determined that this project should be reduced and include the date the project applicant was notified of the reduction. (limit 750 characters)

The CoC reduced project AL0176 for the following reasons: Sub-recipient's failure to meet the CoC's expectations regarding grant spend-down/financial management resulting in remaining grant funds to be recaptured by HUD. Historically, the project continues to struggle with its budget during the grant's period of performance which has included grant extensions and budget amendments, in addition to receiving adequate guidance and administrative support from the grant's recipient and the CoC. The reallocated funds from this project will support a new high-priority DV project in Baldwin County, Alabama, part of the CoC's geographical area.
