# **Request for Proposals**

Homeless Coalition of the Alabama Gulf Coast Continuum of Care AL-501 for Mobile County and Baldwin County, Alabama Issued November 24, 2025

#### INTRODUCTION

The U.S. Department of Housing and Urban Development (HUD) has released the FY2025 Notice of Funding Opportunity (NOFO) for homeless assistance through HUD's Continuum of Care Program.

The Collaborative Applicant for the Homeless Coalition of the Alabama Gulf Coast (AL-501), is accepting proposals for new projects and renewal projects for HUD CoC Program funding.

New and renewal projects will compete for available funds. All projects meeting the threshold requirements will be eligible for project ranking/prioritization for funding by the Homeless Coalition of the Alabama Gulf Coast. HUD will then award funds based on the CoC Application score and project criteria as outlined in the FY2025 NOFO.

### **ELIGIBLE APPLICANTS**

To be eligible for CoC Program funding under this NOFO, project applicants must meet all eligibility and threshold requirements contained in the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11381-11389) (the Act) as Amended by the HEARTH ACT, the CoC Program Interim Rule (24 CFR part 578) (the Rule), the FY2025 CoC Program Competition (NOFO), and any HUD-published CoC Program guidance for new and renewal project applications as this information becomes available from HUD (Currently, HUD has only released the NOFO).

NOTE: There are significant changes and requirements in the FY2025 CoC Program Competition NOFO. Applicants should carefully and thoroughly review the entire NOFO for detailed information on the goals and objectives of the NOFO, program descriptions, project applications, eligibility criteria, and scoring information.

FY2025 CoC Program NOFO AL-501

Prior to submitting an application, applicants should ensure they meet the following threshold criteria in addition to any criteria outlined in the FY2025 HUD CoC Competition Notice of Funding Opportunity published by HUD:

- 1) Applicant has a valid UEI (Unique Entity Identifier) number
- 2) Applicant has no outstanding delinquent Federal debts
- 3) Applicant has no debarments and/or suspensions
- 4) Applicant has an accounting system
- 5) Applicant must disclose any violations of Federal criminal law
- 6) Active registration in the System for Award Management (SAM)
- 7) Applicant must demonstrate eligibility by providing the following:
  - a. Signed authorization to apply for CoC funding
  - b. Most recent IRS 990
  - c. Most recent audit report and auditor's management letter
  - d. By-laws
  - e. Articles of incorporation
  - f. IRS 501(c)(3) designation letter
  - g. Current board roster including at least one homeless or formerly homeless member
  - h. Copy of budget for the last operating year, the current operating year, and the next operating year if available
  - i. Copy of Code of Conduct/Ethics, Conflict of Interest Policy, and personnel, procurements, and accounting procedures
  - j. Agreement to utilize the HMIS (or a HUD-approved comparable database for DV providers)
  - k. Match commitment letter including anticipated match sources and type (cash or in-kind contribution)

## **ELIGIBLE PROJECTS**

Continuum of Care funds can be used for projects under the following four program components (NOFO p. 15):

- 1. Permanent Housing (PH)
- 2. Transitional Housing (TH)
- 3. Supportive Services Only (SSO)
- 4. Homeless Management Information System (HMIS)

Note: The Homelessness Prevention component is not an eligible component through this CoC's program.

Within the four program components listed above the following types of project applications are eligible for submission in the FY2025 Program Competition.

1) CoCs may apply for the following types of new projects created with CoC Bonus or through Reallocation (FY2025 NOFO pp. 37):

- a. Permanent Housing-Permanent Supportive Housing (PH-PSH) Projects
- b. Permanent Housing-Rapid Rehousing (PH-RRH) Projects
- c. Transitional Housing (TH) Projects
- d. Dedicated HMIS project for the costs at 24 CFR 578.37(a)(4) that can only be carried out by the HMIS lead
- e. Supportive services only (SSO-CE) project to develop or operate a centralized or coordinated assessment system.
- f. Supportive Services Only (SSO).
- 2) CoCs may apply for new Domestic Violence (DV) projects created through DV Bonus or DV Reallocation Process subject to the provisions outlined in the FY2025 NOFO (p.35):
  - a. Permanent Housing-Rapid Rehousing (RRH) Projects
  - b. Transitional Housing (TH) Projects
  - c. Supportive Services Only-Coordinated Entry Project
- 3) Expansion Project HUD will allow project applicants to apply for expansion projects subject to the provisions outlined in the FY2025 NOFO (p. 40) through reallocation, CoC bonus and DV bonus processes.
- 4) Consolidated Project HUD will allow project applicants to use the consolidation process to combine two or more eligible renewal projects (e.g., permanent housing-permanent supportive housing projects) subject to the provisions outline in the FY2025 NOFO (p. 42).
- 5) Transition Grant HUD will fund a new CoC project through the reallocation process to transition an eligible CoC renewal project from one program component to another eligible component over a 1-year period subject to the provisions outlined in the FY2025 NOFO (p. 44)
- 6) Renewal Grants Projects may renew under the CoC Program NOFO to continue eligible activities. Renewal grants are subject to the Renewal Project Requirements outlined in the FY2025 NOFO (p. 45).

#### **DEADLINE**

All Proposals must be received by the Collaborative Applicant (HOPE for All Gulf Coast) no later than **4:00 PM on Tuesday, December 9, 2025**.

#### SUBMISSION PROCEDURE

Please complete the **FY25 HUD New Project Form** to prepare and submit a new proposal. The form and relevant guidance will be available on the CoC's website (<u>al501coc.org/resources/NOFO</u>) and updated as new information becomes available from HUD. (*Currently, HUD has only released the NOFO. Project Application Forms and Detailed Instructions for completing same are not available*). Submit one hard-copy and electronic copy (via email) of the proposal with a cover letter signed by the organization's authorized representative, as follows:

By mail or hand delivery: (NOTE: Any application <u>not</u> received by mail on or before the published deadline will not be accepted. <u>Applications post-marked on the deadline will be rejected</u>. Applicants are encouraged to hand deliver original applications.
